*I authorize employees and officials of the City of South Bend and/or the Flood Control Zone District No. 1 of Pacific County the right to enter and remain on the property in questions to determine whether a permit should be issued and whether special conditions should be placed on any issued permit. I have the legal authority to grant such access to the property in question.*

*I also acknowledge that if a permit is issued for land development activities, no terms of the permit can be violated without further approval by the permitting entity. I understand that the granting of a permit does not authorize anyone to violate in any way any federal, state or local law/regulation pertaining to development activities associated with a permit.*
